As a guest or member, you are required to abide by the following:

1. Paradise Lakes Resort is a private, member's only club.
2. Behavior or activity that disrupts the harmony and tranquility of the club is not permitted. Disruptive behavior/activity includes any physical or verbal activity that is abusive or defames any member, guest, employee or the resort.
3. Overt sexual behavior, or the appearance of overt sexual behavior, is not permitted. If anyone's behavior offends you, please report it to the management immediately.
4. FREE EVENTS at Paradise include the main pool areas & Key West. They DO NOT include LAKESIDE!
5. TAKING PHOTOGRAPHS IS NOT PERMITTED anywhere on the premises at anytime.
6. Persons under the age of 18 are not permitted in the recreational areas after 5 PM
7. Persons under the age of 21 are not permitted in the recreational areas after 9 PM
8. Pets are not permitted on the club grounds.
9. GLASS IS NOT PERMITTED outside of the restaurant or night club.
10. Solicitation of any business or any service on the club grounds is strictly prohibited without a club license.
11. Food and beverages NOT purchased in the club are not permitted in the night club, poolside or recreational areas.
12. Please sit on your towel in all areas when nude.
13. Personal music/TV devices may be used only with earphones in the club recreational areas.
14. Chairs and chaises may not be "reserved" for an extended period of time.
15. Swimming in the lake is not permitted.
16. There is NO lifeguard on duty; swim in the pools at your own risk.
17. Running, diving, horseplay, and toys are not permitted. Floats and rafts are not permitted on holidays and weekends.
18. Please shower with soap each time, before you enter a pool or hot tub.
19. Failure of a member to pay a debt to Paradise Lakes Resort for any financial obligation incurred shall constitute grounds for membership suspension or revocation.
20. Owners, renters, and club members are responsible for their guest's behavior and daily membership fees must be paid prior to entering the club recreation area.
21. The Paradise Lakes Resort grounds consists of the main club, restaurants, pools and pool areas, bars, nightclub, tennis courts, and the south club known as Lakeside including tennis courts, sand volleyball courts, pickleball courts and pools.
22. The grounds are surrounded by private condominium areas. Your membership fees allow you the use of only the Paradise Lakes Resort grounds.
23. Scheduled events and activities are subject to change and or cancellation.
24. There are NO refunds or credits for canceled, suspended or revoked memberships.
25. Your behavior is the determining factor in the length of stay at Paradise Lakes Resort; your visit and or membership may be terminated with or without cause at any time.
